The Division is grateful to Dr. Bill Sandborn for his leadership as Chief of Gastroenterology and Hepatology since 2011. His 10 years of leadership has been consequential in many ways, including massive faculty recruitment, development and expansion of specialized sub subspecialty clinical service lines, markedly increasing the clinical footprint of the Division, creation of the nationally recongized UCSD Inflammatory Bowel Disease Center, creation of advanced training fellowships in inflammatory bowel disease and hepatology, the transformation the GI Fellowship into one of the most highly rated programs in the US, two renewals of the NIH T32 research fellowship training grant, the creation of the San Diego Digestive Disease Research Center funded by a P30 GI center grant, and significant expansion of both NIH and VA funded research as well as industry sponsored clinical trials.

Under Dr Sandborn's leaders, US News and World Report ranked UCSD as the #1 Global University for Gastroenterology and Hepatology in the world for research achievements in 2020. US News and World Report in 2020 also ranked UCSD Gastroenterology and GI #32 in the United States for clinical care.


During his time as UCSD GI Chief, Dr Sandborn maintined his amazing IBD research productivity. During his decade at UCSD, he published 497 peer reviewed publications, bringing his career total to 849 peer reviewed publications. This includes 14 original articles in the New England Journal of Medicine (11 as 1st, co-1st, or senior author), of which 8 were published during his time at UCSD. In 2019 he was awarded the Sherman Prize for his contributions to inflammatory bowel disease.

In the summer of 2020, Dr. Sandborn co-founded a San Diego based biotechnology company called Shoreline Biosciences, focused on cell therapy for various oncology indications, using engineered NK cells and macrophages derived from induced pluripotent stem cells, with chimeric antigen receptors (CARs) based on discoveries from the UCSD laboratory of Dan Kaufman. In May 2021, Dr. Sandborn left UCSD to become the Chief Medical Officer for Shoreline Biosciences. He will maintain an academic appointment at UCSD, and a small clinical IBD practice training the next generation of IBD leaders. We wish him the best in his new pursuits we are delighted that he will continue to maintain an academic appointment and a clinical presence here at UCSD.



He has made significant contributions in clinical care and received several accolades, including "Top Doctor" in San Diego for 15 consecutive years and the 2019 Master Endoscopist award from the American Society of Gastrointestinal Endoscopy. He serves as Chief Experience Officer for the Health System and was recognized for his efforts by Becker's Hospital Review as "30 Hospital and Health System Chief Experience Officers to Know in 2018" and "25 Hospital and Health System Chief Experience Officers to Know in 2020".


Joseph Meserve, MD

Joe enjoyed his experience with clinical research as a resident at UCSD. In 2019, and after residency was recruited and joined the Gastroenterology fellowship program as a research fellow. His first year was clinical training in developing clinical skills and knowledge in gastrointestinal diseases, and July 2020, appointed to the Training Grant of Gastroenterology. His plans after completing his gastroenterology fellowship and T32 research training is to continue working on clinical research in an advanced fellowship in IBD.

Dr. Joseph Meserve is currently a second-year gastroenterology fellow and a postdoctoral research trainee on the GI Division T32 Training Grant. Dr. Meserve's research concentrates on the safety and clinical outcomes of biologic therapy in inflammatory bowel disease. The initial focus of his research was to inform on real-world outcomes and safety of vedolizumab, an anti-integrin biologic for the treatment of Crohn's disease and ulcerative colitis.

He recently completed a large retrospective analysis of neonatal outcomes in fathers with immunemediated diseases both exposed and unexposed to immunosuppressive medications and biologics utilizing a national claims database (see Graphic Abstract). Currently, he is building a new database to inform on longitudinal changes in outcomes and safety with changes in treatment which will provide a scaffold to answer other unique questions in the realm of IBD.


